Hello Cory-

I am responding on behalf of the City of Mountain View Community Development and Public Works Departments regarding any past, present, and reasonably foreseeable probable future projects for Permanente Creek for your consideration.

1. Permanente Creek Trail – Charleston Road and Amphitheatre Parkway Crossings, CIP 14-38. This project includes two creek crossings in the North Bayshore area. The project is substantially complete.
2. Colony Street Connection to Permanente Creek Trail, CIP 18-48. Includes a Ped/Bike bridge across Permanente Creek. Currently in design.
3. McKelvey Park. The baseball park acts as a stormwater basin for creek flows and was done in partnership with Valley Water. The project is complete.
4. Permanente Creek Widening and New Bike/Ped Bridge. Not a CIP, being done as part of a Google development project at 1860-2159 Landings Drive. The project proposes improvements to Permanente Creek and its riparian habitats through widening of the creek and restoration of native vegetation to help support local biodiversity. A pedestrian-bicycle path is proposed along the eastern side of Permanente Creek and would connect to a new east-west pedestrian/bicycle bridge over the creek. The bridge would also provide pedestrian and bicycle access between the Landings office building and the Huff garage. The western bank of the creek will be widened to create plantable slopes, allowing planting of riparian and wetland species for new habitat areas and to buffer the existing creek. The bridge crossing and creek improvements will be designed to accommodate the base flood elevation of the creek and maintain existing flood protection measures. In design.
