Third Quarter 2020 Noise Monitoring Report for Lehigh Southwest Cement Company 24001 Stevens Creek Blvd. Cupertino, CA 95014

In the third quarter of 2020, the Department of Environmental Health (DEH) received no complaints related to noise in the vicinity of the Lehigh Cement Plant. We performed three different measurements in two different locations (where neighbors had filed a complaint earlier) as presented in Table 1 below.






