When the fee is exhausted, owner/applicant will be required to pay additional fees to cover the cost of staff time to process/review application. The hourly rate for actual cost application is \$153.

For Williamson Act Compatible Use Determination applications, the hourly rate includes \$130 for the Division of Agriculture, which will be billed against the minimum fee.

(1) Any fees not paid within forty five (45) days of invoicing shall be subject to interest charged at a rate equal to that earned by the County Treasury investment pool for that period.
