(1) Concurrent/Combined permit applications will consist of 100% of the main/base fee to be collected and all subsequent associated permit fees will be charged at 75% of the published fee. The term "main/base fee" refers to the following Planning permit fees: Administrative Architecture and Site Approval, Architecture and Site Approval (excluding Sign permits), Building Site Approval (excluding Verifications and Pre-Applications), Design Review, Grading, Miscellaneous Planning Applications/ Projects, Subdivision (excluding Pre-Applications), Use Permits (excluding Pre-Applications and Urban Restaurant) and Variance (excluding Pre-Applications). The term "base fee" does not include review fees collected by Sections, Divisions, Departments, or Agencies outside of the Planning Division. Thus, when review is required by Building, Fire Marshal's Office, Land Development Engineering, Surveyor's Office, Department of Environmental Health, Roads and Airports Department, or any other Division, Department, or Agencies, the published fees will be charged.

(2) For services that are billable, a minimum non-refundable fee will be charged at the time of intake/commencement. When the fee has been exhausted to cover County costs, the owner/applicant will need to pay additional fees to cover costs incurred by the County to complete the service.

(3) Fees from Roads and Airport Department (RDA) may apply as per RDA fee schedule.

(4) Fees from Department of Environmental Health (DEH) may apply as per DEH fee schedule.
