Building Official and/or Fire Marshal may approve any such alternate, provided it is found that:

- 1. The proposed alternative material, design or method of construction is satisfactory and complies with the intent of the provisions of this code, and
- 2. The proposed material, method or work offered is, for the purpose intended, not less than the equivalent of that prescribed in this code as it pertains to Quality, Strength, Effectiveness, Fire resistance, Durability and Safety.

Sufficient evidence shall be submitted to substantiate any claim regarding its use.

- 2 Submit the application along with all supporting evidence (reports, calculations, manufacturer's instructions, etc.) to the InSite public portal.
- A review fee is due at time of submittal. For Development Services review <u>only</u>, the submittal fee is \$321.73. For Fire Marshal's Office review <u>only</u>, the submittal fee is \$402. For <u>both</u> Development Services and Fire Marshal's Office review, the submittal fee is \$723.73.
- 4 Your application will be reviewed. Supplemental review fees may be charged if the time necessary to review the submittal and prepare findings exceeds two hours.
- When sufficient information is provided, a written_decision to "approve," "approve as revised," or "deny" will be made.
