Individual Resources v. Historic Districts

Individual Resource

Can be a building, structure, object, or site.

Historic District

- National Parks Service "a geographically definable area, urban or rural, possessing a significant concentration, linkage, or continuity of sites, buildings, structures, or objects united by past events or aesthetically by plan or physical development."
- Contributing v. Non-Contributing
- Contiguous v. Discontiguous



ESA

Evaluating a Potential Historic District

- **1. Context:** What is the story?
- 2. Period of Significance: When was the story formed?
- 3. Survey: What is still there? And where is it located?
 - Potential Contributors
 - Potential Boundaries
- **4. Integrity:** How altered are potential contributors?
 - Districts have lower integrity requirements
 - The grouping is more important than any one contributor



NASA Ames

National v. State v. Local Eligibility

- National Register of Historic Places (54 U.S.C. 306108)
- California Register of Historical Resources (PRC Section 5024.1)
- Santa Clara County Historic Preservation Ordinance (Ord. No. NS-1100.96, Division C17) any evaluated building, structure, object, or site.

Designation Criteria

- 50 years old or older
- Retains Historic Integrity
- Qualified under one or more significance Criteria

Significance Criteria

- Events
- Persons
- Architecture/Construction/Design
- Information Potential

County Historic District Designation Process

County Historic District Designation Process

Zoning Ordinance § 3.50.080 covers the process of adoption of an Historic (-h) District

- Must contain at least one site, building, or structure which is a *registered historic cultural resource*
- Definition of *registered historic cultural resource*: Any building, site, structure, object, or district which is registered in the National Register of Historic Places, California Historical Landmarks Program, California Register of Historical Resources, California Points of Historical Interest Program, or *formally designated as such by a resolution of the Santa Clara County Board of Supervisors*.
- Formally Designated Designated County Landmark

Landmark Designation Process

Covered under County Ordinance Division C17 - Article II – Landmark Designation

- Initiated by owners (or authorized representatives), HHC, or Board of Supervisors
- Needs to meet the following criteria
 - > Fifty years or older
 - Retains historic integrity
 - > Meets one or more of the following criteria of significance:
 - 1. Associated with events of significant contribution to local or regional history/cultural heritage;
 - 2. Associated with lives of persons important to local, California or national history;
 - 3. Embodies distinctive characteristics of type, period, region, construction, or represents work of a master or possesses high artistic values; or
 - 4. Yielded or has potential to yield information important to pre-history or history of the local area, California, or nation.

Other Preservation District Ordinances

Zoning Ordinance Chapter § 3.40 - "-n" Neighborhood Preservation Combining District

- Purpose is to provide neighborhood-specific development standards for certain urban unincorporated areas
- Augments base zoning district regulations to better address particular area's historic development patterns and characteristics; discrepancies between the standards of the County and the adjoining city; and unique area-specific development issues.
- Are prepared as Zoning Overlay and are established via Planning Commission recommendations & Board Approval
