County to Hold Community Outreach Meetings on Proposed Countywide Inclusionary Housing Ordinance

WHAT:

The County of Santa Clara is proposing a Countywide Inclusionary Housing Ordinance that would apply to the development of three or more housing units in the unincorporated areas of Santa Clara County (excluding Stanford University properties¹ and incorporated cities). The proposed Ordinance would address the need for affordable housing within Santa Clara County by requiring 16% of units within a new development of three or more residential units be dedicated as affordable housing.

The proposed Inclusionary Housing requirements would not apply to residential developments that propose one or two new units, Accessory Dwelling Units (ADU), Junior Accessory Dwelling Units (JADU), Community Care facilities, or Agricultural Employee Housing.

As a part of the community outreach effort, the public is invited to attend a community meeting held virtually via Zoom. The County encourages comments and participation from the public, especially from those interested in these changes or those proposing subdivisions or development of three or more residential units in the unincorporated areas of the County.
