Submit a total of two (2) complete revised sets of printed plans (24" X 36"), and one (1) electronic copy of the revised plans on a USB / Flash Drive, which address the following items.

- 1. The Lot Line Adjustment Lot Sizes table shown near the upper left corner of the site plan must be placed within the "white space" along the righthand border of the site plan. This table must summarize all changes to affected parcels. This information must include: existing lot square footage, proposed lot square footage, total square footage changes, and, percentage of change to each individual lot.
- 2. Along the North and South perimeters of Parcel A there are notes showing the distance from the front of the parcel to the new location of the proposed adjusted line. Eliminate that note in its present location as it appears to suggest that you are moving the lot lines closer to the two road frontages, whereas that line denotes a P.S.E. which exists at along those locations. Have the P.S.E. shown / labeled more prominently to eliminate confusion.

 - Minnie Marie Chiri, as trustee of the Joseph Chiri Marital Trust, dated December 28,
 1990; and
 - Ronald J. Chiri, a married man as his sole and separate property.

4. On the site plan, label the structure immediately west of the listed BARN. If this structure has any plumbing fixtures at all, show the location of the associated leachfield. If no plumbing fixtures exist or are proposed, along with the labeling of the structure, place a note stating that no plumbing fixtures exist in the structure.

Ensure the requested changes are made for the revised plan sets and documents that are needed for the resubmittal. Resubmittals are only accepted by appointment with the assigned project planner (Carl Hilbrants). If the requested information is not submitted within 180 days, you will be required to pay a fee of 10% of the application fee at the time the information is submitted. All requested information must be submitted no later than one (1) year from the date of this letter. PARTIAL RESUBMITTALS WILL NOT BE PROCESSED. Fees required at the time of resubmittal will be those in effect at that time.
