Hi Kavitha,

The properties are located in a 2040 General Plan designation of Lower Hillside (LH).

I have reviewed the *Rural Residential (RR)* designation (as described in <u>Book B</u>) would like to point out some differences between the County's RR and the City's LH designations.

The intent of the LH designation is to "maintain [land] largely as open space" and "to preserve the visual and habitat benefits of open space areas." The designation allows for limited infill in scale and location to preserve the open space areas and to complete the existing pattern of development in the area. At a high level, the 2040 General Plan has Goal LU-17 for hillside and rural preservation – "Preserve the valuable natural resources of the hillsides, and protect their aesthetic and habitat amenities to enhance the rural character of these areas." Also, our General Plan Policy LU-17.1 states that the future development allowed will be consistent with or below planned or existing densities to maximize resource conservation.

The County's RR designation states that the intent of the designation is "primarily for residential purposes" (R-LU 56c).

Other hillside related policies focus on the future design of a development. I have attached a description of the Lower Hillside General Plan designation and hillside-related policies. As long as the County can make findings that the Rural Residential designation as applied to these properties would be consistent with the City's Lower Hillside designation and hillside preservation policies, City staff is fine with the designation change.
