### *Lot Legality*

1. Pursuant to County Ordinance Code [Section C12-229\(b\)\(1\)](#), the lots to be merged must be legal. Legality verification for lots within APN 331-11-076 is required. Please submit the deed for the property that was in effect on June 25, 1969 with the same configuration as the current deed, the deed showing first transfer of title after June 25, 1969, and the current deed. This information is necessary to ensure that the lot in its current configuration was conveyed before 1969 and thereafter.

The following deeds included in the submission have been reviewed:

- Grant deed #3264460 (7811-OR-658), recorded on 8/7/1967. This deed was for APN 331-11-075 only and is not relevant to the project area.
- Quit claim deed #2815514 (6889-OR-74), recorded on 3/19/1965. This deed was for APN 331-11-075 only and is not relevant to the project area.
- Joint tenancy deed #2649927 (6547-OR-232), recorded on 6/18/1964. This deed was for APN 331-11-087 only and is not relevant to the project area.
- Joint tenancy deed #1956625 (5082-OR-558), recorded on 2/24/1961. This deed was for APN 331-11-087 only and is not relevant to the project area.

All requested documents must be complete with no missing pages, and the deeds must be clearly readable. Please provide the book and page number of the document. If the deed includes more than one lot or parcel, note on the deed which description pertains to the requested parcel.
