DISCUSSION

This project was noticed and placed on the Zoning Administration Hearing for September 5, 2024, after the project application was deemed complete. During the September 5, 2024, Zoning Administration hearing, the item was continued to a date uncertain by the request of the applicant to do more outreach and address comments and concerns of neighboring residents in regard to the proposed projects. The Zoning Administrator Hearing Officer granted a continuance for Item No. 2 at the hearing.

BACKGROUND

On October 31, 2023, an application for Architecture and Site Approval was submitted for a new wireless telecommunications facility and was deemed incomplete on November 30, 2023. The resubmission of the application took place on June 27, 2024 and the application was deemed complete on July 26, 2024. The tolling of the application shot clock has been agreed to in written agreement (attachment A) from the applicant and by the siting authority, the County Department of Planning and Development, via written mutual agreement between the applicant and the Zoning Administrator Hearing Officer (approval authority) pursuant to 47 Code of Federal Regulations (CFR) 1.6003(D). The tolling period for this application is paused on September 5, 2024 until mutual agreement between applicant and approval authority for a new hearing date.
