- 1. The proposed overall site plan (sheet A-1) is not complete, as it does not show the following:
  - a) Centerline, road width, rights-of-ways of Raimundo Way;
  - b) Centerline, road width, rights-of-ways of Stanford Avenue;
  - c) Proposed setbacks measured from property lines;
- 2. The submitted enlarged site plan (sheet A-2) is not complete. Please provide the following:
  - a) Centerline, road width, rights-of-ways of Raimundo Way;
  - b) Centerline, road width, rights-of-ways of Stanford Avenue;
  - c) Proposed setbacks measured from property lines;
  - d) Location, common name, diameter of existing trees located near improvements, measured 4.5 feet above grade, and dripline of those trees;
- 3. Provide a grading quantity table listing separately the proposed cut and proposed fill amounts for the tower installation, the grading for the access, the grading for the equipment pad(s) etcetera. If no grading is proposed, state "no grading is proposed' under the scope of work.
- 4. If any landscaping is proposed, which does not seem to be the case looking at the submitted plans, provide a separate landscape plan identifying new landscaping components and, if applicable, any landscaping components proposed for removal.
- 5. Provide the Construction and Logistics Plan, indicating laydown areas for contractor parking, storage of tools, materials, and stockpiles.
- 6. Provide color and/or material samples for the proposed pole, faux canopy, antennas, and fence enclosure. The color samples must be presented using the county-approved color board which can be found at the following URL: <a href="https://stgenpln.blob.core.windows.net/document/DR\_ColorMatBoard.pdf">https://stgenpln.blob.core.windows.net/document/DR\_ColorMatBoard.pdf</a>. Ensure that all samples list the Light Reflectivity Value (LRV) and that LRV is 45 or less. The color shall be well-adapted design that exhibits consistency in tree size, character and color to that of the surrounding vegetation, that results in the design being well-adapted to local context.
- 7. Provide the height information for the proposed cabinet.
- The application form included in the submission is outdated. Please complete, sign, and submit the County Planning Master Application Form available at <u>https://stgenpln.blob.core.windows.net/document/MasterAppForm.pdf</u>. The most recent version of this form includes "Section III - Notice of Levine Act And County Of Santa Clara Lobbyist Ordinance".

If the requested information is not submitted within 180 days, you will be required to pay a fee of 10% of the application fee at the time the information is submitted. All requested information must be submitted within 1 year of the date of this letter and will not be accepted after 1 year. PARTIAL RESUBMITTALS WILL NOT BE PROCESSED. Fees required at the time of resubmittal will be those in effect at that time.

In submitting this land use application, the owner/applicant included an initial application fee. Application fees are categorized as "fixed fees" and "billable fees", based on the particular application types. "Fixed fee" applications do not require any additional fees to continue processing. However, when funds associated with a "billable fee" application have been spent, an additional deposit will be required to continue processing the application. As of the date of this letter, approximately 35% of the initial deposit associated with your "billable fee" application has been spent on the processing of your application.
