NOTICE OF AVAILABILITY OF A DRAFT PROGRAM ENVIRONMENTAL IMPACT REPORT FOR THE COUNTY OF SANTA CLARA RURAL ZONING AMENDMENTS AND AGRICULTURAL IMPACT THRESHOLD (STATE CLEARINGHOUSE NO. 2022030776)

July 21, 2025

A Draft Program Environmental Impact Report (PEIR) has been completed in accordance with the California Environmental Quality Act (CEQA) and is now available for review. The County of Santa Clara is the Lead Agency preparing the PEIR for the Rural Zoning Amendments and Agricultural Impact Threshold (Project). Pursuant to CEQA, the County must issue a Notice of Availability (NOA) to inform responsible, trustee and other agencies which have jurisdiction by law, as well as the public, that a Draft PEIR has been prepared, and to seek public comments on the document. Any agencies with jurisdiction over the proposed Project will need to use the PEIR prepared by the County when considering their own approval actions and should comment on information germane to the agency's statutory responsibilities. Members of the public are also encouraged to comment on the Draft PEIR. The Draft PEIR evaluates the potential environmental impacts of the project and recommends mitigation measures for any significant impacts, as required.

The proposed Project would amend the County of Santa Clara Zoning Ordinance as it pertains to the Exclusive Agriculture (A), Agricultural Ranchlands (AR), Hillsides (HS), and Rural Residential (RR) zoning districts and establish a threshold of significance for evaluating impacts to agricultural resources from development proposed on farmland. The Project would clarify, simplify, and standardize the permit process for agriculture-supportive uses, align development in the Exclusive Agriculture zoning district with existing County land use policies, and replace the current "local-serving" provisions with new objective development standards. The Project would also establish a threshold of significance to evaluate agricultural impacts on a project-by-project basis under CEQA. The Draft PEIR finds that the project may result in a potentially significant impact to agricultural resources through conversion of farmland to non-agricultural uses. The Draft PEIR also evaluates potential mitigation measures to reduce these impacts.

In further compliance with CEQA Guidelines Section 15087, this notice reports that the County contains sites listed on hazardous materials databases complied pursuant to Government Code Section 65962.5. Future projects subject to the proposed Zoning Ordinance Amendments or Agricultural Impact Threshold would be required to comply with existing federal, State, and local regulations, programs, and County General Plan policies that are intended to prevent and/or reduce potential impacts associated with hazardous conditions. Additionally, known hazardous materials sites would be required to comply with California Code of Regulations Title 22 regulations related to the inspection, remediation, and cleanup of sites representing hazardous conditions or containing hazardous materials.
