# County to Hold Rescheduled Community Outreach Meetings to Present an Update on the Proposed Zoning Amendments for Non-Residential Uses in Rural Districts

#### WHAT:

The County of Santa Clara is inviting the public to attend rescheduled community meetings, intended to present updates on the proposed Zoning Ordinance amendments for non-residential uses in rural districts. These meetings are in-lieu of cancelled south County meetings previously scheduled for Tuesday, February 19, 2019 and Thursday, February 21, 2019.

The initial modifications were meant to apply the same zoning regulations to all assembly uses within the rural base zoning districts (Agriculture, Agriculture Ranchlands, Hillsides, and Rural Residential). These amendments do not apply to uses that are identified as primary uses in the rural areas, or uses that are allowed by right, such as single-family residential use, open space or natural resources, and agriculture.

The County encourages comments and participation from the public, especially from those interested in these changes or proposing commercial, industrial, recreational, or institutional uses in the rural districts.
